# Ridge Runners Sled Dog Racing Club

## Code of Conduct for Forestry Access

Ridge Runners Sled Dog Racing Club (RRSDRC) has access to a number of forests in the lower North Island for the purposes of Sled Dog Racing ONLY. Sled Dog Racing is defined as a dog and/or dogs being attached by lead to a rig, scooter, bike or person.

Entry into Forestry that RRSDRC has access to must conform with the below requirements.

All members must carry membership cards with them at all times.

Access to the forestry is restricted to **MEMBERS ONLY** unless an event is taking place and an RRSDRC committee member is present. Non-members can only be taken into the forest with prior agreement by the executive committee. This is due to insurance purposes.

All members can request access to any forest RRSDRC has access to by request to the secretary who will make arrangements with other users of the forest and then post an event.

If driving a vehicle in the forest, headlights must be on at all times.

Failure to adhere to the above conditions may put your membership to RRSDRC in jeopardy.

- I agree that any derogatory remarks, spreading of malicious rumours or making any negative reference towards or about the Ridge Runners Sled Dog Racing Club, other Club members or other Clubs and their members or mushers, may result in “Forfeiture of Membership”, if grounds for such are deemed sufficient by the Committee.
- I agree that the display of good sportsmanship in and during all competitions, exhibitions, meetings or social activities in which I partake, including internal club, national, or international activities is vital.
- I am aware that the approach of my activity will influence trail access and land management decisions, and I will abide by all access and usage rules instigated by RRSDFRC and trail owners.
- I will attempt to keep well informed in the field of Sled Dog Racing and if needed I will seek advice including within the community of Sled Dog racing.

I will be bound by the abovementioned Code of Ethics and any ensuing additions or amendments that shall be determined from time to time.
